

SWEEPSTAKES OFFICIAL RULES

ELIGIBILITY: The Sweepstakes is open only to legal residents of the United States and the District of Columbia (“U.S.”) who are at least eighteen (18) years of age on the date of the Sweepstakes entry submission (“Entrant”).
